PERMIT BOX COMPANY WILL NOT BE HELD LIABLE FOR ANY ACTIONS, REPRESENTATIONS, WARRANTIES, OR GUARANTEES PROMOTED OR ADVERTISED BY DISTRIBUTORS.

INDIVIDUALS WILL BE REQUIRED TO SUBMIT A CREDIT APPLICATION AND REFERENCES BEFORE RECEIVING APPROVAL AS A DISTRIBUTOR.
